Cancellation Policy

If Exhibitor cancels this Agreement for any reason whatsoever, then Exhibitor must immediately provide Show Management Notice of Cancellation, as defined herein. In addition, Exhibitor agrees and understands that cancellation of this Agreement may subject Exhibitor to a partial or total forfeiture of Payment, as described herein.

a. Notice of Cancellation.

If Exhibitor cancels this Agreement for any reason whatsoever, then Exhibitor must immediately provide Show Management Notice of Cancellation ("Notice of Cancellation") in writing. Further, Exhibitor must direct Exhibitor's written Notice of Cancellation to Show Management at the email addresses or physical address, as set forth hereunder.

Notice of Cancellation is deemed complete upon Show Management's written acknowledgement of receipt of Notice of Cancellation.

b. Cancellation Seventy-Five Days before Show.

If Exhibitor provides Show Management Notice of Cancellation in writing in accord with the procedures as detailed herein at least ninety days before the first published date of the Show, then Exhibitor understands and agrees that Exhibitor will forfeit \$1,000.00 of Exhibitor's Payment ("Forfeited Payment"). Additionally, Exhibitor will receive a partial refund of 75% of any amounts received by Show Management in excess of Exhibitor's Forfeited Payment.

c. Cancellation Sixty Days before Show.

If Exhibitor provides Show Management Notice of Cancellation in writing in accord with the procedures as detailed herein at least sixty days before the first published date of the Show, then Exhibitor understands and agrees that Exhibitor will forfeit \$1,000.00 of Forfeited Payment. Additionally, Exhibitor will receive a partial refund of 50% of any amounts received by Show Management in excess of Exhibitor's Forfeited Payment.

d. Cancellation After Payment Deadline Expires.

If Notice of Cancellation is received within 59 days of the first published date of the Show, then Exhibitor will forfeit any portion of any Payment made to Show Management. Further, if this Agreement is executed within 59 days of the Show, then Payment is nonrefundable even if participation is cancelled.

e. Failure to Issue Notice of Cancellation.

Exhibitor understands and acknowledges that failing to comply with the procedures of Notice of Cancellation, as set forth herein, will cause Exhibitor to remain obligated under this Agreement.
